

Honeywell #OperationJetSet Sweepstakes – Official Rules

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED AND IN COUNTRIES INDICATED BELOW. PARTICIPATION IN THIS SWEEPSTAKES CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES.

1. Eligibility: NO PURCHASE NECESSARY. VOID WHERE PROHIBITED BY LAW. To be eligible to participate in the Honeywell International Inc. #OperationJetSet Sweepstakes (“Sweepstakes”), you must be: (1) above the age of majority in the state, country or province where you reside at the time of entry; and (2) a resident of an eligible country. Residents of the following countries are **not** eligible to participate in the Sweepstakes: Sweden, Portugal, Italy, Australia, Poland, Brazil, Saudi Arabia, Malaysia, Cuba, Iran, Iraq, Syria, North Korea, Sudan, Libya, Liberia, Zimbabwe, Myanmar (Burma). If an entrant wins either prize and is unable to utilize the prize (or any aspect of the prize) for any reason, the entrant will **not** be entitled to a replacement prize or cash substitution. 2. Sponsor: The sponsor of this Sweepstakes is Honeywell International Inc., located at 1944 East Sky Harbor Circle North, Phoenix, AZ 85034, USA (“Sponsor” or “Honeywell”).

3. Term: The Sweepstakes begins on **May 14, 2018** at 10:00 a.m. EDT and ends on **July 2, 2018** at 5:00 p.m. EDT (“Term”). Entries submitted outside the Term will be disqualified.

4. How to Enter: To participate, during the Term, you simply go to aerospace.honeywell.com/operationjetset and fill out the registration form available at that page. **LIMIT: ONE ENTRY PER PERSON.** Any use of automated, robotic, macro, programmed or similar quick-entry programs, or attempts to exceed the maximum number of entries permitted, is prohibited and will result in disqualification.

Sponsor is not responsible for late, lost, damaged, stolen, misdirected, mutilated, garbled, incomplete, undelivered, or inaccurate registrations or entries, all of which may be disqualified at sponsor’s sole discretion. Proof of transmission (screenshots or captures, etc.) does not constitute proof of submission. All entries become the property of Sponsor and in no case shall be returned to entrant.

If a dispute arises regarding who submitted an entry, the entry will be deemed to be submitted by the authorized account holder of the email address provided in the registration form. Authorized account holder is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address.

5. Drawing Date and Time: On July 3, 2018 at 9:30 a.m. EDT Honeywell will randomly select three potential winners from the pool of eligible entries submitted via the entry method described above in Section 4. The first potential winner selected will be eligible to win the Flight Test Experience; the second potential winner selected will be eligible to win a free one-year subscription to Honeywell's GoDirect Flight Planning. The third potential winner selected will be eligible to win a bag of promotional items. All prizes are described below in Section 6. An entrant is not a winner of any prize unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete. Honeywell will announce the winners' names on our twitter account @honeywell_aero at 10:00 a.m. EDT on July 5, 2018. Following the announcement Honeywell will reach out directly to the three winners with the contact information provided in the entry form.

Except where prohibited by law, potential winners must complete an Affidavit of Eligibility and Liability and Publicity Release ("Affidavit") in accordance with the instructions listed in the prize notification correspondence. The potential winner of the Flight Test Experience (described below in Section 6) may be required to execute additional release documents related to the use of that prize. This includes a personal tour of Honeywell's 757 test airplane near Sky Harbor International Airport in Phoenix, AZ; a meet and greet with the Honeywell Flight Test team, a ride in our King Air aircraft at the Sky Harbor International Airport and walk through of our AeroVu cockpit as well as a look at our experimental Honeywell technology. Later in the day the experience will include a tour of our GoDirect Flight Services operation center and our satellite communications lab at our 1944 E Sky Harbor Circle location. This prize will include a \$1,400 voucher to be used towards the winner's travel expenses to Sky Harbor International Airport. **NOTE:** Winners are responsible for any costs or expenses not specifically detailed in the prize description above. This includes any lodging or other travel expenses associated with the Flight Test Experience prize beyond the \$1,400 voucher included in the prize. Sponsor will coordinate with the winner in an effort to plan a date for the Flight Test Experience that is convenient for both the winner and Sponsor. While Sponsor will make a reasonable effort to accommodate the winner's preferences, Sponsor cannot guarantee that any particular date(s) will be available. **NOTE:** This prize is intended for, and most likely to be utilized by a certified pilot or licensed dispatcher. The approximate retail value ("ARV") of the Flight Test Experience is \$2,900.

Second Place Prize. One-Year Subscription to GoDirect Flight Planning. One (1) winner will receive a one-year subscription to GoDirect Flight Planning, a flight planning service offered by Honeywell. If you win this prize and are unable to utilize the GoDirect Flight Planning

services for any reason, you will not be entitled to a replacement prize or cash substitution. The ARV of the GoDirect Flight Planning subscription is \$2,000.

Third Place Prize. One bag of promotional items. One (1) winner will receive a bag containing various Honeywell promotional items. The ARV of the promotional items bag is \$100.

11. Governing Law & Disputes: The Sweepstakes is subject to all federal, state, and local laws. The Sweepstakes and Official Rules are governed and interpreted by the laws of the State of Arizona, without regard to any conflict of law provisions. If the parties do not agree to conference or are unable to resolve a dispute after such a conference, the parties agree that exclusive jurisdiction for any dispute, claim or demand related in any way to the Sweepstakes or these Official Rules will be decided by binding arbitration. All disputes between the parties, of whatsoever kind or nature arising out of these Official Rules, shall be submitted to JAMS for binding arbitration under its applicable rules then in effect, before one arbitrator to be mutually agreed upon by both parties. The parties agree to share equally in the arbitration costs incurred.
